Nature and effects of request #2021-01-0001:

The purpose of the request for minor exemption is to regularize the rear setback. The rear setback would be established at 5 metres, as shown on a plan dated January 14, 2021, prepared by Mr. Jacques Bonneau, Land Surveyor, under minute 17768. The standard established by Schedule C of Zoning By-law Number 264-2008 is that the rear setback must be 25 meters.

Identification of the site concerned:

The site covered by this application is located at 9, chemin Fuller in West Bolton, on lot number 5 192 433 of the Quebec cadastre (roll number: 8606-68-6954) and located in zone PRES-3.

047-0221 CPTAQ - 18 TUER ROAD - REQUEST FOR USE FOR A PURPOSE OTHER THAN AGRICULTURE

- to inform applicants that the Municipality cannot be held responsible for any inconvenience due to noise and dust that may be related to the establishment of a residence so close to an extraction site
