MINISTRY OF TRANSPORTATION - LOCAL ROAD
MAINTENANCE ASSISTANCE PROGRAM - BASIC
COMPENSATION TO MUNICIPALITIES - CERTIFICATION

WHEREAS the Ministry of Transportation, Sustainable Mobility and Transportation Electrification has paid compensation in the amount of \$247,462 for the maintenance of the local road network for the 2020 calendar year;

WHEREAS the compensations paid to the Municipality concern the routine and preventive maintenance of local roads 1 and 2 as well as bridge elements located on these roads, for which the Municipality is responsible;

IT WAS MOVED by Councillor Gilles Asselin, SECONDED by Councillor Loren Allen and resolved that the Municipality of West Bolton inform the *Ministère des Transports, de la Mobilité durable et de l'Électrification des transports* of the use of compensations for the routine and preventive maintenance of local roads 1 and 2 as well as the bridge components located on these roads, for which the Municipality is responsible, in accordance with the objectives of the Local Road Maintenance Assistance Program.
