# 1. West Bolton Family and Seniors Policy

# 1.1 Who is the policy for ...

A family residing in West Bolton brings together individuals of all ages, connected by a relationship of kinship, alliance or belonging. It can consist of a family in the traditional sense (one or two parents with one or more children), a couple, or a single person. These include those who are designated as seniors, either based on the legal definition of the term (65 years or older) or based on the need for support resulting from their degree of autonomy.

Any citizen, regardless of their status, and in particular if they are in a precarious situation, can benefit from the family and seniors policy by virtue of their sense of belonging to the municipality which makes them a member of the great family of West Bolton.

#### Definition of the term "senior":

A person is referred to as a "senior" either based on the legal meaning of the term (65 years of age or older) or on the need for support resulting from their degree of autonomy.

#### Principles related to active aging:

The concept of active aging advocated by the WHO and the Government of Quebec refers to the process of optimizing opportunities for good health, participation and safety in order to increase the quality of life in old age.

The three pillars of participation, health and safety are reflected in the nine areas of action that are particularly important for seniors to function in everyday life, stay in touch with a network of relationships and participate in activities according to their preferences and abilities.

# 1.2. Issues identified through the survey

The analysis of the results of the survey consultation allowed the committee members to identify:

- The most pressing issues for families and seniors in West Bolton;
- The needs and subjects that required clarification via the citizen consultation.

#### Built environments

#### **Outdoor spaces and infrastructure**

Analysis and issues:

Respondents' responses touch on three types of needs:

⇒ Access to marked public walking trails as well as safe bike paths and a children's playground;



- ⇒ Access to bathing points: on the one hand, respondents seem to have little knowledge of the existing offer of bathing points. On the other hand, access to Douglass Beach is difficult, both in terms of costs and limited access to parking;
- ⇒ Access to a community building or a gathering place for social activities.

#### **Transport and mobility**

Analysis and issues:

Respondents' responses suggest three types of issues:

- ⇒ The feeling of safety on roads and paths, with regard to speed, road conditions and cohabitation between different users. These issues appear to have an impact on residents' lifestyles in terms of physical activity;
- ⇒ Lack of knowledge and/or difficulty in accessing certain services;
- ⇒ The long distances to travel to the different sectors of the municipality, which lead to difficulties in service delivery.

#### Housing and living environment

Analysis and issues:

Respondents' responses focus on the issue of the type of housing available:

- ⇒ On the one hand, older people feel that one of the reasons that would make them leave West Bolton is the difficulty of maintaining their home and yard;
- ⇒ On the other hand, a number of respondents say they are interested in different housing options. Out of 129 respondents to this question, 33 people are interested in a residence for autonomous or semi-autonomous people, 28 in intergenerational homes and 20 in affordable homes.

#### Social environments

#### Social participation, respect and inclusion

Analysis and issues:

Respondents' responses touch on two types of issues:

- ⇒ Everything related networking and socialization: the absence of a gathering place does not promote meetings and exchanges, especially for the elderly;
- ⇒ Everything related to cohabitation and respect for each other: there are notable issues of cohabitation on roads and paths, but also some concerns about the different visions of long-term residents versus newcomers from large cities. Some comments are also reported regarding the non-respect of private land.



#### Leisure and culture, structured or individual

Analysis and issues:

Respondents' responses mainly express a lack of close-by activities (which are nonetheless available in surrounding municipalities):

- ⇒ Lack of activities for children, adolescents and young people;
- ⇒ Lack of leisure activities for all ages: cultural, artistic, sports, social...;
- ⇒ Lack of opportunities and activities that promote a physically active lifestyle.

However, there seems to be some ignorance of the services offered.

The issue of what is actually available or not, consistent with the interests of families and seniors in West Bolton, also needs to be addressed.

It should also be noted that nearly one-third of respondents make it a priority to provide better access to the activities of surrounding municipalities.

Finally, there is some interest in individual or unstructured activities such as walking, cycling, sports on playgrounds...

- ⇒ Walking trails are named as the second priority by more than a third of respondents;
- ⇒ Regarding the question on specific activities for children, it is finally the park/playground that comes first in terms of priorities for two-thirds of respondents to this question (64 people out of the 116 respondents to this question). However, this proposal ranks last in the previous question on priorities for the general population (11 of the 228 respondents to this other question).

#### **Communication and information**

Analysis and issues:

⇒ There is a lack of knowledge of services and what is happening in the municipality for many respondents.

#### Health and social services

Analysis and issues:

- ⇒ Several services are available to West Bolton residents, but they seem to be poorly known;
- ⇒ Members of the committee are concerned about the isolation of certain more vulnerable people;
- ⇒ The size of the territory and the distance between the different sectors make it difficult to set up home services.

#### Safety

Analysis and issues:

⇒ Respondents' responses mainly relate to the issue of safety on roads and paths, in relation to the speed of certain motorists and the cohabitation of different road users;



⇒ The few residents concerned about the distance of first responders deserve to be reassured about the effectiveness of the service provided to the population of West Bolton.

#### 1.3. Items submitted for consultation

A citizen consultation took place on November 20, 2021 to clarify some important needs identified via the survey. This collective discussion activity brought together 29 citizens of West Bolton, including 20 people aged 65 and over.

The objectives of this citizen consultation were to:

- Share information about the current portrait of the municipality;
- Share highlights of the survey results;
- Consult the public on identified needs to clarify the municipal action plan.

The issues and guestions submitted to the public are described below.

The results of the consultation were considered in identifying possible solutions and in preparing the action plan.

#### **OUTDOOR SPACES, INFRASTRUCTURE AND LEISURE**

- ACCESS TO INFRASTRUCTURE
- ⇒ Lack of access to marked walking trails, safe bike paths and a children's playground.
- ⇒ Lack of access to bathing points: the existing offer is poorly known, access to Douglass Beach is difficult.
- ⇒ No place (room, building) to hold leisure or social activities on site.
- LACK OF ACTIVITIES
- ⇒ Lack of on-site activities for children, teenagers and young people, for all ages.
- ⇒ Lack of opportunities, activities that promote a physically active lifestyle.
- LACK OF KNOWLEDGE
- ⇒ Lack of knowledge of the activities offered by other municipalities.
- ⇒ A question of coherence between what is available and the interests of families and seniors in West Bolton.

Which inter-municipal agreements are of interest to seniors and families for recreation? Which activities? What financial support?



#### **HOUSING**

This theme was added as a concern to be addressed by consultation participants.

- ⇒ On the one hand, older people feel that one of the reasons that would make them leave West Bolton is the difficulty of maintaining their home and yard;
- ⇒ On the other hand, a number of respondents say they are interested in different housing options. Out of 129 respondents to this question, 33 people are interested in a residence for autonomous or semi-autonomous people, 28 in intergenerational homes and 20 in affordable homes.

#### SOCIAL PARTICIPATION, RESPECT AND INCLUSION

- ISOLATION
- ⇒ Members of the committee wonder about the isolation of certain more vulnerable people, particularly seniors and those with loss of autonomy.

How to get to know them better? How to better reach them? Make them better aware of the services? How to support them?

- FEW NETWORKING OPPORTUNITIES AND LOCATIONS
- ⇒ No access to a community building or room to allow for on-site social activities.
- $\Rightarrow$  Lack of a gathering place to promote meetings and exchanges, especially for the elderly.

How to create opportunities for networking, meeting and exchange? What and how are you ready to get involved?

- COHABITATION ISSUES
- ⇒ Notable issues of cohabitation on roads and paths, but also some concerns about the different visions of long-term residents versus newcomers to large cities. Some elements are also reported regarding the non-respect of private land.

#### **HEALTH AND SOCIAL SERVICES**

- LACK OF KNOWLEDGE
- ⇒ Several services available in the surrounding municipalities, but they are poorly known.

How can we better give people access to information?

- LACK OF ACCESS
- ⇒ Community, social and health services are offered in other municipalities, which involves travel.
- ⇒ The size of the territory and the distance between the different sectors make it difficult to set up home services, including services for seniors.



How can we develop a sense of belonging to the surrounding municipalities?

#### **SECURITY**

- ⇒ Major safety issue on roads and paths, relating to the speed of some motorists and the cohabitation of different road users.
- ⇒ No on-site gathering place in case of emergency.

Which actions could the municipality take to improve the sense of security of families and seniors?

- Outdoor spaces and buildings
- Transport and mobility
- Housing
- Social development
- Recreation, culture and community life
- Communication from the municipality to citizens
- Health and social services
- Security

# 1.5. The objectives of the policy

Based on the analysis of the social diagnosis, the results of the survey and the citizen consultation, the five objectives selected for the policy are as follows:

- 1. Seniors and families have access to the services to which they are entitled;
- 2. Seniors and families benefit from an intergenerational, strong and supportive social network;
- 3. Seniors and families have access to a diverse and enriching leisure and cultural offer;
- 4. Seniors and families live in their homes, move around and use outdoor spaces safely in West Bolton;
- 5. The municipality is exploring opportunities to offer housing alternatives adapted to the needs of seniors and families.

## 1.6. Values and principles of intervention

#### **Values**

Sense of belonging and cooperation;



- Respect for each other, equality, justice;
- Respect for tranquility and the rural environment;
- Generosity and benevolence, empathy, a sense of service.

#### The principles of intervention

- Creativity, openness, flexibility, to find solutions to problems, think outside the box and meet needs;
- The clarity and honesty of the objectives, the directions to be taken;
- Consistency between the data collected, the comments of the population and the orientations of the policy.



# 2. Family and Seniors Policy Action Plan

West Bolton's family and seniors policy is inclusive. One of the goals of the plan was to be able to provide support to anyone in need regardless of age. Therefore, most of the actions contained in this plan are not limited to individuals of a specific age group. Rather, it aims at implementation strategies that are diversified and adapted to the specific conditions of the target populations. For example, communication actions involve the use of various mediums to ensure that seniors and vulnerable people have access to information.

Here are specific actions for each of the objectives of the policy:

#### 1. Seniors and families have access to the services to which they are entitled

- 1.1. Communicate and widely promote the existing service offer to which families and seniors are entitled.
- 1.2. Put in place strategies that allow people to share information with each other.
- 1.3. Facilitate access to certain health and social services for families and seniors.

# 2. Seniors and families benefit from a social network, including ntergenerational, strong and supportive networks

- 2.1. Identify and support people who are isolated based on their need for social networks.
- 2.2. Promote opportunities and spaces for networking and meeting for families and seniors, by fostering intergenerational activities.

#### 3. Seniors and families have access to a diverse and enriching leisure and cultural offer

- 3.1. Widely communicate the existing activity offer to which seniors and families are entitled.
- 3.2. Improve access to the supply of existing activities and infrastructures.
- 3.3. Promote the development of a local offer of activities for families and seniors.

#### 4. Seniors and families live in their homes, move around and use outdoor spaces safely

- 4.1. Identify and support the most vulnerable people based on their safety needs.
- 4.2. Cooperate with partners to secure roads and paths, while respecting each other's expertise.

# 5. The municipality explores opportunities to offer housing alternatives adapted to the needs of seniors and families

5.1. Explore the development of different housing models adapted to the needs of different types of households.
